*<sup>1</sup> TFP, or total factor productivity, is an important indicator in measuring the productivity of the economy. Essentially, TFP is the “residual” source of growth after accounting for the contribution of the different factors of production, such as labor and capital. It therefore captures the contribution of technological advance and of other factors that improve the overall efficiency of the economy.*
