REQUEST FOR EXPRESSION OF INTEREST FOR THE ADVISORY SERVICES FOR THE VALUE ANALYSIS (VA) OF INFRASTRUCTURE PROJECTS (LONG-TERM CONSULTANT)

1. The National Economic and Development Authority (NEDA), through its VE/VA Fund, intends to apply the sum of **Nineteen Million Pesos (PhP19,000,000.00) for a period of two (2) years**, inclusive of all applicable taxes, accommodation, plane fare, other incidental expenses and printing of the original Reports being the Approved Budget for the Contract (ABC) to payments under the contract for the above-mentioned consulting services.
2. The NEDA now calls for the submission of eligibility documents for the above-mentioned consulting services. The Terms of Reference [TOR] can be downloaded free of charge from the website of the Philippine Government Electronic Procurement System and the website of NEDA. Interested consultants must submit their eligibility documents (**see Annex C of the TOR**) on or before **November 17, 2014, 12:00 noon** at the address below. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion. Eligibility requirements/documents may however be submitted in advance for preliminary evaluation by NEDA for completeness/compliance. Opening of eligibility documents will be held on **November 17, 2014, 1:30 PM** at the Infrastructure Staff Conference Rm., 3rd Flr. NEDA-sa-Pasig Bldg., 12 St. JM Escrivá Drive, Ortigas Center, Pasig City.
3. The NEDA Bids and Awards Committee shall **draw up a list of three (3) shortlisted consultants** from those who submitted eligibility documents/Expression of Interest and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR), which will be entitled to submit bids. The criteria and rating system for short listing are indicated in **Section X of the TOR**.
4. Bidding shall be conducted through open competitive selection/ bidding procedures as specified in the IRR of RA 9184. Bidding is open to local or foreign bidders, subject to the conditions for eligibility provided in the IRR of RA 9184.
5. The bids/proposals shall be evaluated using the Quality-Cost Based Evaluation/Selection (QCBE/QCBS) procedure. The criteria and rating system for the evaluation of bids shall be provided in the Instructions to Bidders.
6. The contract shall be completed as specified in the TOR.
7. The NEDA reserves the right to reject any and all bids/proposals including a single eligible bid/proposal, annul the bidding/selection process, or not award the contract without thereby incurring any liability to the affected bidder or bidders.
