





REQUEST FOR EXPRESSION OF INTEREST FOR ADVISORY SERVICES FOR THE PUBLIC PRIVATE PARTNERSHIP – CAPACITY BUILDING PROJECT (PPP-CBP)

1. The National Economic and Development Authority (NEDA) through the PPP-CBP Fund intends to apply the sum of Two Million Eight Hundred Forty Thousand Pesos (**PhP2,840,000.00**), inclusive of all applicable taxes, being the Approved Budget for the Contract (ABC) to payments under the contract for the above-mentioned services.
2. The NEDA now calls for the submission of qualification documents by **individual consultants** for the above-mentioned advisory services. The Terms of Reference [TOR] can be downloaded free of charge from the website of the Philippine Government Electronic Procurement System and the website of NEDA. Interested **individual** consultants must submit their Curriculum Vitae (CV) in accordance with Section IV of the TOR with a covering letter of intent (LOI) on or before **December 15, 2014, 12:00 noon** at the address below. Opening of submissions will be held on **December 15, 2014, 12:30 p.m.** at the Infrastructure Staff Conference Rm. 3rd Flr. NEDA-sa-Pasig Bldg., 12 Escrivá Drive, Ortigas Center, Pasig City.
3. The NEDA Bids and Awards Committee shall draw up a list of up to three (3) shortlisted individual consultants from those who submitted CV /LOI and have been determined as qualified in accordance with the TOR and the pertinent provisions of RA 9184 and its IRR, who will be entitled to submit bids.
4. Bidding shall be conducted through open competitive bidding procedures for individual consultants consistent with the IRR of RA 9184. Bidding is open to local or foreign bidders, subject to conditions that may be provided for in RA 9184 and its IRR.
5. The bids/proposals shall be evaluated using the Quality-Cost Based Selection (QCBS) procedure. The criteria and rating system for the evaluation of bids shall be provided in the bid documents.
6. The contract shall be completed within 8 months (approximately 6 man-months).
7. The NEDA reserves the right to accept or reject any bid, including that of the single eligible bidder, waive any minor deviation in the bid which will not materially affect the substance of the bid and to annul the bidding process at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
