

Particular	Clarification/Amendment
a. Applicable Experience/Expertise	<p>Minimum 5 years of applicable experience/expertise in similar and relevant projects in the <b>infrastructure sector</b> will be required.</p> <p><i>Similar Projects</i> - refer to contracts with scope of works covering policy review/formulation, advisory services, capacity building, among others, for the conduct of VE/VA of infrastructure projects. <i>Similar projects</i> may also include the conduct of pre-Feasibility Study (F/S) or FS with options analysis/choice of alternatives</p> <p><i>Relevant Projects</i> - refer to contracts with scope of works covering the conduct of pre-F/S or F/S in the infrastructure sector. Detailed engineering may also be considered "relevant".</p>
b. Educational Attainment	<p>Educational attainment in related fields shall be considered. <i>Related fields</i> are as follows:</p> <ul style="list-style-type: none"> <li>• Engineering, Physical and Related Sciences</li> <li>• Economics, Finance, Mathematics and Related Sciences.</li> </ul>
c. Statement of Completed Contracts	<p>The Statement of Completed Contracts (Form A) should specify contracts completed in the <b>last 20 years</b>.</p>
