REQUEST FOR EXPRESSION OF INTEREST (REI) AND SIMULTANEOUS SUBMISSION OF ELIGIBILITY DOCUMENTS, TECHNICAL AND FINANCIAL PROPOSALS FOR THE RE-BIDDING OF THE CONSULTING SERVICES FOR THE CONDUCT OF VARIOUS FEASIBILITY STUDIES (F/S)

1. The **National Economic and Development Authority** intends to apply the following sums as Approved Budget for the Contract (ABC) for the re-bidding of the procurement of consulting services for the conduct of the corresponding F/S:

The NEDA Bids and Awards Committee for Consulting Services (NBAC-CS) now calls anew for the simultaneous submission of Eligibility Requirements, Technical and Financial Proposals for each of the above procurements, **IN THREE (3) SEPARATE SEALED ENVELOPES**, pursuant to the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act, **on or before 23 November 2015, 12:00 noon** at the following address:

3. NEDA will hold a Pre-proposal Conference **on 10 November 2015** at the same address stated above. Only those Consultants who will be paying the corresponding fee of PhP2,000.00 for each procurement will be allowed to participate in the Pre-proposal Conference. Proponents who have previously paid the participation fee in the first round of bidding for the subject procurements are not required to pay the same for this next round of procurements.

4. The Terms of References (TOR) for the undertakings, including the Eligibility Requirements/Criteria and Eligibility Data Sheet (EDS) and Instruction to Bidders, among others, may be downloaded from the NEDA website, <http://www.neda.gov.ph>.
5. The following criteria shall be applied in the short-listing of Consultants and evaluation of Technical and Financial Proposals:
 - a) Short-listing Criteria:
 - i. Experience and Capability of the Firm (30%);
 - ii. Quality of Key Personnel who may be assigned to the Project (50%); and
 - iii. Job Capacity (20%).
 - b) Criteria for Evaluation of Technical and Financial Proposals:
 - i. Technical Proposal (80%):
 1. Experience and Capability of the Firm;
 2. Key Personnel Proposed to be assigned to the Project; and
 3. Plan of Approach and Methodology.
 - ii. Financial Proposal (20%)
6. Class "A" documents, including Tax Clearance, may be submitted in advance, but not **later than 10 November 2015**, for preliminary evaluation of compliance, provided that the Consultant has already paid the corresponding participation fee **on or before 10 November 2015**.
7. The envelopes containing the eligibility documents/requirements will be opened first **on 23 November 2015**. Only the technical proposals of the eligible and shortlisted firms will be opened on a date that will be disclosed to the shortlisted firms. The technical and financial proposals of the non-shortlisted firms shall be returned to the respective firms unopened. The bids/proposals shall be evaluated using the *Quality-Cost Based Evaluation (QCBE)* procedure.
8. NEDA reserves the right to reject any and all proposals, including that of a single eligible proponent, waive any minor deviation in the submitted documents, which will not materially affect the substance of the bid, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected participating consultants/consulting firms.
