Consulting Services for the Preparation of Terms of Reference (TOR), Design Parameters and Tender Documents for the Design and Construction of the New NEDA Building



Hereunder are further clarifications and additional information on the above procurement:

Particulars	Clarification/Amendment
A. Qualification of the Firm	<p>The definitions for similar and relevant projects in the Terms of Reference (TOR) are further revised to read as follows:</p> <p><u>Similar projects</u> refer to contracts with scope of works related to the preparation of tender documents, contract administration/management, architectural design and detailed engineering of government / public and private buildings. The government/public and private buildings should be at least 3-storeys in height.</p> <p><u>Relevant Projects</u> shall refer to contracts with scope of works related to the preparation of tender documents, contract administration / management, architectural design and detailed engineering of infrastructure projects. Relevant projects shall also include government / public and private buildings which are lower than 3-storeys in height.</p>
B. Reporting/Deliverables and Payment Schedule	<p>On the 2nd deliverable indicated in Section VII of the TOR, the phrase "<i>Electric Design Computations including the Design Parameters</i>" is excluded such that said deliverable will read as "<i>Submission of the Result of the Topographic and Boundary Survey, Soil Boring Test and Seismic Analysis</i>".</p>
C. Criteria for Shortlisting	<p>Additional information to Section X of the TOR under criterion 2 (Quality of Key Personnel of the Firm) is provided below:</p>

	<p>As part of the submission of eligibility documents, the duration of trainings attended must be indicated <i>in days or weeks</i>. Otherwise, the training/s will not be considered in the evaluation. Training Certificates should be ready if and when required.</p> <p>Further, the italicized note found in Bid Bulletin No. 1 is tightened with the phrase “under oath (notarized)” such that it will read as follows:</p> <p><i>Note: Key personnel who are not organic to the firm shall be required to submit a letter certifying their commitment under oath (notarized) to render services to the firm for the engagement if awarded the contract.</i></p>
D. Eligibility Criteria Form A: Statement of Completed Contracts	<p>Following the revised provision of Section 2.1.a (iv) of the Eligibility Data Sheet (EDS) found in Bid Bulletin No. 1, Instruction item (b) of Form A is revised accordingly such that it will read as follows:</p> <p>b) State completed contracts for the last <i>20 years</i>. Contracts that are similar to the project being bid in terms of nature and amount shall be prioritized in inclusion in the list.</p>
