### REQUEST FOR EXPRESSION OF INTEREST (REI) AND SUBMISSION OF ELIGIBILITY DOCUMENTS FOR THE CONSULTING SERVICES FOR THE DEVELOPMENT OF A MODEL TO DETERMINE THE INDUSTRY-SPECIFIC IMPACT OF THE ASEAN ECONOMIC COMMUNITY TO THE PHILIPPINES

1. The **National Economic and Development Authority** intends to apply the sum of Six **Million Two Hundred Thousand Pesos (PHP6,200,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of consulting services for the conduct of the subject consultancy services.
2. The NEDA Bids and Awards Committee for Consulting Services (NBAC-CS) now calls for the submission of Expression of Interest (EOI) and eligibility requirements as provided for under the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act" and the Terms of Reference (TOR). Interested individual consultants and consulting firms may submit their eligibility documents **on or before 10 May 2016, 12:00 noon** at the following address:


3. The TOR for the undertaking including the Eligibility Requirements/Criteria can be downloaded from the NEDA website, [http://www.neda.gov.ph/?page\\_id=256](http://www.neda.gov.ph/?page_id=256).
4. Only those consultants who will submit EOI and pay the corresponding participation fee of Php 2,000.00, together with the required eligibility documents, and determined to be eligible and shortlisted shall be directly invited in the subsequent selection process and allowed to purchase the bid/proposal documents.

The NBAC-CS will evaluate legal and financial eligibility documents, including Tax Clearance, submitted in advance, but **not later than 03 May 2016**, to determine Consultant's compliance with the eligibility requirements, provided that the Consultant has already paid the aforementioned participation fee on or before the foregoing date.

5. The bids/proposals shall be evaluated using the *Quality-Cost Based Evaluation (QCBE)* procedure.

6. NEDA reserves the right to reject any and all proposals, including that of a single eligible proponent, waive any minor deviation in the submitted documents, which will not materially affect the substance of the bid, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected participating consultants/consulting firms.
