

b. Eligibility Requirements and Shortlisting	<p>Only individual consultants may participate in the bidding process for this Consulting Services. Consulting Firms, however, may nominate a consultant (organic or otherwise) to participate in the bidding process provided it shall comply with the Eligibility Requirements for Firms as provided in Section 2.1 of the Eligibility Documents / Eligibility Data Sheet (EDS).</p> <p>For the shortlisting process, the nominated consultant shall be evaluated based on his/her educational background, training attended/conducted and other skills, and various work experiences (including all completed and ongoing contracts regardless of relevance/similarity to the subject undertaking).</p>
c. Consultant's Remuneration and Reimbursable	<p>The Approved Budget for the Contract (ABC) is Two Million, Eight Hundred Fifty Thousand and 00/100 Pesos (PhP2,850,000), inclusive of all applicable government</p>
