TO ALL BIDDERS:

Following the Pre-Bid Conference held last 7 June 2016, hereunder are the modifications and clarifications relative to the following procurements:

Project A: Provision of Janitorial Services for the National Economic and Development Authority (NEDA-sa-Pasig) Under a Three (3)-Year Service Agreement

1. Delete last column of Annex "B", Statement of Single Largest Completed Contract Similar to the Contract to be Bid.
2. The following paragraph shall be added under Item 33.2 of the Bid Data Sheet:

"The performance security, if in the form of a bank draft/guarantee, shall be valid for six (6) months and be replaced every after six (6) months."
3. Use DOLE-RTWPB Wage Order No. NCR-19 effective April 4, 2015, Providing for a Wage Increase in the National Capital Region, as basis in accomplishing the Breakdown of Annex "A" of Bid Form under Section VIII (Bidding Forms).
4. Item 17 of the Breakdown of Annex "A" which states "Administrative Overhead Cost and Margin"

Please be guided by the following GPPB Issuances:

- a. Policy Matter 03-2012 issued on November 30, 2012 which states that, "considering the obvious conflict between Section 31 of RA 9184 and Section 9(b)(ii) of DOLE DO 18-A, we express the view that the latter should be considered invalid, and thus cannot be a source of any right, duty, obligation or power."
- b. Resolution No. 14-2012 issued on June 1, 2012, Declaring Section 9(b)(ii) of DOLE Department Order No. 18-A Violative of Article IX, Section 31 of Republic Act No. 9184 and its Revised Implementing Rules and Regulations (IRR).

- c. RESOLUTION NO. 26-2013 issued on April 26, 2013, Denying the Request of the DOLE for Reconsideration of Government Procurement Policy Board (GPPB) Policy Matter (PM) Opinion No. 03-2012 dated 30 November 2012.
5. Remove items A.1 to A.3 and B.1 of Annex "H", Minimum Supplies and Materials Requirements. A new provision shall be added to include inspection and acceptance of all supplies delivered as scheduled by the NEDA Inspectorate Team.

Project B: Provision of Security Services for the National Economic and Development Authority (NEDA) Buildings in Pasig City and Makati City Under a Three (3)-Year Service Agreement

1. Use DOLE-RTWPB Wage Order No. NCR-19 effective April 4, 2015, Providing for a Wage Increase in the National Capital Region, as basis in accomplishing the Breakdown of Annex "A" of Bid Form under Section VIII (Bidding Forms).
2. Item of the Breakdown of Annex "A" which states "AGENCY FEE (Administrative Overhead and Margin)"

Please be guided by the following GPPB Issuances:

- a.
