REQUEST FOR EXPRESSION OF INTEREST (EOI) AND SIMULTANEOUS SUBMISSION OF ELIGIBILITY DOCUMENTS, TECHNICAL AND FINANCIAL PROPOSALS FOR THE PROCUREMENT OF EVALUATION CONSULTANT FOR THE MONITORING AND EVALUATION (M&E) FUND

1. The National Economic and Development Authority (NEDA), through the Monitoring and Evaluation Staff (MES), shall engage the services of an Evaluation Consultant (foreign or local) to jumpstart and ensure the efficient and effective conduct of (i) monitoring and evaluation, and other related studies, in priority areas; and, (ii) capacity building activities for NEDA and selected stakeholders. The Approved Budget for the Contract (ABC) is **TWO MILLION, EIGHT HUNDRED FIFTY THOUSAND and 00/100 PESOS (PhP2,850,000.00)**, inclusive of all applicable government taxes and charges.
2. The NEDA now calls for the simultaneous submission of Eligibility Documents, Technical and Financial Proposals, in three (3) separate sealed envelopes, for the conduct of the abovementioned undertaking in accordance with the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, or the Government Procurement Reform Act (GPRA), and the Eligibility Data Sheet (EDS) / Instructions to Bidders (ITB)¹. Interested Consultants (individual or otherwise) should submit their Eligibility Documents, Technical and Financial Proposals on or before **19 July 2016 (Tuesday), 12:00 P.M.** at the following address:

3. The Eligibility and Selection will be conducted through open competitive selection process using non-discretionary "pass/fail" criterion as specified in RA 9184 and its Revised IRR. Proposals shall be evaluated using the Quality-Based Evaluation/Selection (QBE/QBS) procedure. The criteria with rating system for the evaluation of proposals shall be provided in the ITB.
4. Consultants who will express interest to participate in the subject procurement and simultaneously submit the Eligibility Documents, Technical and Financial Proposals by the deadline set in this Request for EOI should first be determined to be eligible pursuant to Sections 24.1 and 24.2 of the Revised IRR of RA 9184 and shortlisted in accordance with applicable experience/qualifications (i.e., track record and qualification of key personnel) and job capacity before their Technical Proposals will be opened and



subsequently evaluated in accordance with Section 33.2.2 of the Revised IRR. The Financial Proposals shall be opened only after the Head of the Procuring Entity (HOPE) has approved the recommendations of the NBAC-CS based on the results of the evaluation of the Technical Proposals.

5. Consultants shall be required to pay the cost of the Bidding Documents of **PhP5,000.00** on or before the Pre-Proposal Conference scheduled on **30 June 2016, 1:00 P.M.**, at the Office of the Assistant Director-General for Investment Programming Conference Room, 4/F NEDA-sa-Pasig Building, #12 Saint Josemaria Escriva Drive, Ortigas Center, Pasig City. Those that have paid the participation fee of **PhP2,000.00**, which shall cover the attendant administrative cost for the eligibility check and shortlisting process, shall be deducted from the cost of the Bidding Documents. The cost of the Bidding Documents, less the participation fee, shall be returned to the Consultant if the same has not been determined eligible and shortlisted.
6. NEDA reserves the right to reject any or all proposals, including that of a single eligible proponent, waive any minor deviation in the submitted documents which will not materially affect the substance of the proposal, annul the bidding process, or not award the contract without thereby incurring any liability to the affected participating Consultant/s.
