REQUEST FOR EXPRESSION OF INTEREST (EOI) AND SUBMISSION OF ELIGIBILITY DOCUMENTS FOR THE PROCUREMENT OF CONSULTING SERVICES FOR THE REVIEW / FORMULATION OF METHODOLOGY FOR THE QUANTIFICATION OF ECONOMIC BENEFITS OF SOCIAL INFRASTRUCTURE PROJECTS

1. The National Economic and Development Authority (NEDA), through the Infrastructure Staff (IS), shall engage the services of a Consultant (individual or firm / foreign or local) for the Review / Formulation of Methodology for the Quantification of Economic Benefits of Social Infrastructure Projects. The Approved Budget for the Contract (ABC) is **TWO MILLION, TWO HUNDRED NINETY-ONE THOUSAND TWO HUNDRED FIFTY AND 00/100 PESOS (PhP2,291,250.00)**, inclusive of all applicable government taxes and charges, professional fees, and other incidental and administrative costs (i.e., transportation/travel expenses, printing, reproduction and packaging of hard and soft copies of reports, expenses for meetings, etc.).
2. The NEDA now calls for the submission of EOI and eligibility requirements for the conduct of the abovementioned undertaking as indicated under Sections 24.1 and 24.2 of the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, or the Government Procurement Reform Act (GPRA), and in the Eligibility Documents / Eligibility Data Sheet (EDS)¹. Interested Consultants should submit their eligibility requirements on or before **20 October 2016 (Thursday), 12:00 P.M.** at the following address:

Only those Consultants who will submit EOI and pay the corresponding participation fee of **PhP2,000.00**, together with the required Eligibility Documents, and determined to be eligible pursuant to Sections 24.1 and 24.2 of the Revised IRR of RA 9184 and shortlisted in accordance with applicable experience/qualifications (i.e., track record and qualification of personnel) and financial/job capacity shall be directly invited in the subsequent selection process.
4. Interested Consultants may submit their Legal, Financial and Class “B” Eligibility Documents, as applicable, in advance (**on or before 11 October 2016, 4:00 P.M.**) for preliminary evaluation by the NBAC-CS in terms of completeness/compliance. The NBAC-CS, however, shall only proceed with the preliminary evaluation when the required participation fee of PhP2,000.00 has been paid. Note that said amount shall



cover the attendant administrative cost for the eligibility check and shortlisting process and shall be deducted from the cost of the Bidding Documents which the participating shortlisted Consultants are required to purchase. The NBAC-CS, after its preliminary evaluation of advance submissions, shall inform the participating Consultants of any deficiency in their respective submissions three (3) calendar days prior to the deadline for submission of Eligibility Documents set in this Request for EOI.

5. Proposals shall be evaluated using the Quality-Cost Based Evaluation/Selection (QCBE/QCBS) procedure. The criteria with rating system for the evaluation of proposals shall be provided in the Instructions to Bidders (ITB).
6. NEDA reserves the right to reject any and all proposals, including that of a single eligible proponent, waive any minor deviation in the submitted documents which will not materially affect the substance of the proposal, annul the bidding process, or not award the contract without thereby incurring any liability to the affected participating Consultant/s.
