REQUEST FOR EXPRESSION OF INTEREST (REI) AND SIMULTANEOUS SUBMISSION OF ELIGIBILITY DOCUMENTS AND PROPOSALS FOR THE CONSULTING SERVICES FOR THE DEVELOPMENT OF A MODEL TO DETERMINE AEC INDUSTRY-SPECIFIC IMPACT IN THE PHILIPPINES

1. The **National Economic and Development Authority** intends to undertake a negotiated procurement of the subject consultancy services in accordance with the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act", with an Approved Budget for the Contract (ABC) of **Six Million Two Hundred Thousand Pesos (PHP6,200,000.00)**.
2. In this regard, prospective consultants are invited to simultaneously submit eligibility documents, technical and financial proposals in three (3) separate sealed envelopes **on or before 13 December 2016, 12 PM** at the Office of the Assistant Secretary for Investment Programming, 4th Floor, NEDA-sa-Pasig Building, 12 Escrivá Drive, Ortigas Center, Pasig City.
3. The eligibility requirements, technical and financial proposal documents and forms including draft General Conditions of Contract (GCC) and Terms of Reference are available from the NEDA website¹. One (1) original copy and four (4) copies of eligibility documents, technical proposals and financial proposals should be enclosed in a single sealed outer envelope. In addition, consultants that have not previously participated in the earlier rounds of bidding are required to pay a participation fee of PhP2,000.00.
4. This procurement is open to Filipino firms/individuals only.
5. NEDA reserves the right to reject any and all proposals, including that of a single eligible proponent, waive any minor deviation in the submitted documents, which will not materially affect the substance of the bid, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected participating consultants/consulting firms.
