

Contract Agreement Form

For the Purchase of One (1) Unit Brand New Motor Vehicle

THIS AGREEMENT made this ____ day of FEB 15 2017 in Pasig City, Philippines, by and between:

The **NATIONAL ECONOMIC AND DEVELOPMENT AUTHORITY (NEDA)** with address at NEDA-sa-Pasig Bldg., No. 12 Saint Josemaria Escriva Drive, Ortigas Center, Pasig City, herein represented by its Undersecretary, **JOSE MIGUEL R. DE LA ROSA**, and hereinafter referred to as the **"Procuring Entity"**;

- and -

The **ISUZU AUTOMOTIVE DEALERSHIP, INC. – PASIG** with address at 102 E. Rodriguez Avenue, Barangay Ugong, Pasig City, herein represented by its Branch Manager, **ALEJANDRO B. PAGUIO**, and hereinafter referred to as the **"Supplier"**;

WHEREAS, upon the invitation of the **Procuring Entity**, the **Supplier** submitted a bid for the Purchase of One (1) Unit Brand New Motor Vehicle in the sum of One Million Three Hundred Fifty Thousand Pesos (PHP1,350,000.00), inclusive of all applicable government taxes and charges (hereinafter called the **"Contract Price"**);

WHEREAS, the **Procuring Entity** subsequently accepted the bid of the **Supplier** pursuant to the NEDA Bids and Awards Committee for Goods and Infrastructure Projects (NBAC-GIP) Resolution No. 03, series of 2017 approved on 27 January 2017.

NOW THEREFORE, the **Procuring Entity** and the **Supplier** have agreed on the following terms and conditions:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Contract, to wit:
 - (a) Bidding Documents, consist of:
 - i. Invitation to Bid;
 - ii. Instructions to Bidders;
 - iii. Bid Data Sheet;
 - iv. General Conditions of Contract;
 - v. Special Conditions of the Contract;
 - vi. Schedule of Requirements and Technical Specifications;
 - vii. Terms of Reference;
 - (b) Supplier's Bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents/statements contained in the Supplier's bidding envelopes, as annexes;
 - (c) Bid Bulletin/Supplemental Bid, if any;

- (d) Performance Security;
 - (e) Credit line issued by a licensed bank, if applicable;
 - (f) Abstract of Bids and Post-Qualification Evaluation Report;
 - (g) NBAC-GIP Resolution No. 36, series of 2016;
 - (h) NBAC-GIP Resolution No. 03, series of 2017;
 - (i) Notice of Award of Contract with the Supplier's *conforme* thereto;
 - (j) Letter of Isuzu Automotive Dealership, Inc. dated 31 January 2017;
 - (k) Letter of Isuzu Automotive Dealership, Inc. dated 06 February 2017;
 - (l) Letter of the Head of the Procuring Entity dated 10 February 2017;
 - (m) Notice to Proceed;
 - (n) Addendum and/or Supplement to the Contract, if any; and
 - (o) Other contract documents that may be required by existing laws and/or the Procuring Entity.
3. In consideration of the payments to be made by the **Procuring Entity** to the **Supplier**, the **Supplier** hereby covenants to deliver one (1) unit brand new mu-X 2.5L automatic transmission motor vehicle in conformity with the provisions of this Contract in all respects.
4. The **Procuring Entity** hereby covenants to pay the **Supplier** in consideration for the delivery of said goods, the Contract Price or such other sum, as may become payable at the time and in the manner prescribed by this Contract.
5. Should any dispute related to this contract and/or the rights of the Parties arise, the same shall be submitted to mutual consultation, mediation and arbitration, in the order of application. The venue of the proceedings shall be at the Pasig City.
6. In case of a court suit, the venue shall be the courts of competent jurisdiction in Pasig City, to the exclusion of all other courts.
