REQUEST FOR EXPRESSION OF INTEREST (EOI) AND SUBMISSION OF ELIGIBILITY DOCUMENTS FOR THE ENGAGEMENT OF AN EVALUATION CONSULTANT FOR THE MONITORING AND EVALUATION (M&E) FUND

1. The National Economic and Development Authority (NEDA), through the M&E Fund under the 2016 General Appropriations Act (GAA) (continuing), intends to apply the sum of **TWO MILLION, EIGHT HUNDRED FIFTY THOUSAND AND 00/100 PESOS (PhP2,850,000.00)**, inclusive of all applicable government taxes and charges, professional fees, and other incidental and administrative costs, as the Approved Budget for the Contract (ABC), to payments under the Contract for the engagement of an Evaluation Consultant for the M&E Fund. Proposals received in excess of the ABC shall be automatically rejected at the opening of the Financial Proposals.
2. The NEDA now calls for the submission of EOI and eligibility requirements for the subject engagement to ensure the efficient and effective conduct of evaluation and related studies in priority areas and the complementary assessment of the evaluation capacity building needs of various NEDA units. The engagement of the Consultant shall be for six (6) man-months over a period of ten (10) months.

Application for eligibility will be evaluated based on a non-discretionary “pass/fail” criterion. Eligibility Documents of interested Consultants must be duly received by the NEDA Bids and Awards Committee for Consulting Services (NBAC-CS) on or before **11 April 2017 (Tuesday), 12:00 P.M.**, at the following address:

Interested Consultants (individual or firm) may obtain further information from NEDA and acquire a complete set of the Proposal/Bidding Documents at the address given above from **Mondays to Fridays, 8:00 A.M. to 5:00 P.M.**, upon payment of the applicable fee for the Proposal/Bidding Documents in the amount of **PhP5,000.00**. The Proposal/Bidding Documents may also be downloaded free of charge from the Philippine Government Electronic Procurement System (PhilGEPS) and NEDA websites, provided that the Consultants shall pay the applicable fee for the Proposal/Bidding Documents not later than the submission of their proposals.
4. The NBAC-CS shall draw up the short list of Consultants from those who have submitted EOI, including the Eligibility Documents, and have been determined as eligible in accordance with the relevant provisions of Republic Act (RA) No. 9184, or the Government Procurement Reform Act (GPRA), and its Revised Implementing Rules and

Regulations (IRR). The short list shall consist of three (3) to seven (7) prospective Consultants who will be entitled to submit proposals. The criteria and rating system for shortlisting are as follows:

* Eligible Consultants should pass the hurdle rate of 70 out of 100 points to be considered shortlisted

5. Proposals shall be evaluated using the Quality-Based Evaluation/Selection (QBE/QBS) procedure. The criteria and rating system for the evaluation of proposals shall be provided in the Instructions to Proponents/Bidders (ITP/ITB).
6. NEDA reserves the right to reject any and all proposals, including that of a single eligible proponent, waive any minor deviation in the submitted documents which will not materially affect the substance of the proposal, annul the procurement process, or not award the contract without thereby incurring any liability to the affected participating Consultant/s.
