Proposals shall be evaluated using the Quality-Cost Based Evaluation/Selection (QCBE/QCBS) procedure at a weight ratio of *80% for the Technical Proposal and 20% for the Financial Proposal*. The technical evaluation shall be based on the following criteria:

b. Plan of Approach and Methodology Substance of the Proposal Completeness of the Proposal Clarity of Methods and Approaches	30%
c. Job Capacity/Current Workload Relative to Capacity	10%

The Consultant must attain a hurdle rate of 70% to be considered based on the abovementioned set of selection criteria.
