<p>Page 9:</p> <p>Class "A" Documents –</p> <p><u>Legal Documents</u></p> <p>PhilGEPS Certificate of Registration and Membership in accordance with Section 8.5.2 of the IRR, except for foreign bidders participating in the procurement by a Philippine Foreign Service Office or Post, which shall submit their eligibility documents under Section 24.1 of the IRR, provided, that the winning Consultant shall register with PhilGEPS in accordance with Section 37.1.4 of the IRR;</p>	<p>Due to the deferment of the implementation of the mandatory submission of PhilGEPS Certificate of Registration and Membership as an eligibility requirement pursuant to GPPB Circular No. 07-2017 dated 31 July 2017, all interested bidders are required to submit Legal and Financial Documents as provided for in Section 24.1 of the 2016 Revised IRR of the RA 9184 as follows:</p> <p><u>Legal Documents</u></p> <p>i) Registration certificate from SEC, DTI for sole proprietorship, or CDA for cooperatives.</p> <p>ii) Mayor's/Business permit issued by the city or municipality where the principal place of business of the prospective bidder is located, or the equivalent document for Exclusive Economic Zones or Areas.</p> <p>In cases of recently expired Mayor's/Business permits, it shall be accepted together with the official receipt as proof that the bidder has applied for renewal within the period prescribed by the concerned local government unit: Provided, That the renewed permit shall be submitted as a post-qualification requirement in accordance with Section 34.2 of this IRR.</p> <p>For individual consultants not registered under a sole proprietorship, a BIR Certificate of Registration shall be submitted, in lieu of DTI registration and Mayor's/Business permit.</p> <p>iii) Tax clearance per E.O. 398, s. 2005, as finally reviewed and approved by the BIR.</p>

	<p><i>Financial Document</i></p> <p>The consultant's audited financial statements, showing, among others, the consultant's total and current assets and liabilities, stamped "received" by the BIR or its duly accredited and authorized institutions, for the preceding calendar year which should not be earlier than two (2) years from the date of bid submission.</p> <p>*The Certificate of PhilGEPS Registration (Platinum Membership) shall remain as a <i>post-qualification requirement</i>.</p>
