<p>On Section V Qualification of the Supplier:</p> <p>As authorized seller/franchised dealer in the motor vehicle sales industry in the Philippines for at least 20 years</p>	<ul style="list-style-type: none">As authorized seller/franchised dealer of the motor vehicle being offered;That the BRAND of motor vehicle being offered has been existing in the Philippines for at least 20 years; and
<p>Submission of Technical and Financial Proposal</p>	<p>Reminders to Bidders</p> <ul style="list-style-type: none">Bid Security may be in any of the following:<ol style="list-style-type: none"><u>Bid Securing Declaration</u> – should be notarized with government-issued ID (<i>Note: CTC is no longer accepted as a competent evidence of identity</i>); or<u>Cash, cashier's/manager's check, bank draft/guarantee/irrevocable letter of credit</u> – 2% of ABC; or<u>Surety Bond</u> – 5% of ABCUse <u>up to date forms</u> (<i>follow the format of the forms included in the bidding documents</i>) and ensure that these are properly notarized (e.g. CV of nominated experts, Omnibus Sworn Statement, Bid Securing Declaration)Deadline for additional queries and requests for clarification is <u>10 calendar days</u> before the deadline for submission of proposals. The NBAC-CS <u>may respond</u> through bid bulletin not

		<p>later than <u>7 calendar days</u> before the deadline for submission of proposals.</p> <ul style="list-style-type: none"> • Only Bidders who have paid the non-refundable participation fee not later than the deadline for submission of bids shall qualify to bid; • Deadline for submission of proposals – Observe timeliness; <u>1 minute late is strictly considered LATE.</u>
Bidding Documents Page 38, BDS 5.5 NFCC		<p>NFCC = [(Current assets minus current liabilities) (15)] minus the value of all outstanding or uncompleted portions of the projects under ongoing contracts, including awarded contracts yet to be started, coinciding with the contract for this Project.</p> <p>However, in the case of procurement of Goods, a bidder may submit a committed Line of Credit from a Universal or Commercial Bank, in lieu of its NFCC computation.</p> <p>If the prospective bidder submits a committed Line of Credit, it must be at least equal to ten percent (10%) of the ABC to be bid: Provided, That if the same is issued by a foreign Universal or Commercial Bank, it shall be confirmed or authenticated by a local Universal or Commercial Bank.</p>
