

Contract Agreement Form

For the Purchase of Color Printers for the National Economic and Development Authority

THIS AGREEMENT made this ____ day JAN 07 2019, 2019 in Pasig City Philippines, by and between:

The **NATIONAL ECONOMIC AND DEVELOPMENT AUTHORITY (NEDA)** with address at No. 12, Saint Josemaria Escriva Drive, Ortigas Center, Pasig City, herein represented by its Undersecretary for Central Support Office, **JOSE MIGUEL R. DE LA ROSA**, and hereinafter referred to as the **"Procuring Entity"**

- and -

BUSINESS MACHINE CORPORATION with address at Carson Bldg. Orense cor. Del Carmen Sts., Guadalupe, Makati City, herein represented by its Government Coordinator, **MYLENE L. PALALAY**, and hereinafter referred to as the **"Supplier"**;

WHEREAS, upon the invitation of the **Procuring Entity**, the **Supplier** submitted a bid for the Purchase of Color Printers for the National Economic and Development Authority (NEDA) in the sum of Eight Hundred Eighteen Thousand, One Hundred Sixty Pesos and 00/100 (PhP818,160.00), inclusive of all applicable government taxes and charges (hereinafter called the **"Contract Price"**);

WHEREAS, the **Procuring Entity** subsequently accepted the bid of the **Supplier** pursuant to the NEDA Bids and Awards Committee for Goods and Infrastructure Projects (NBAC-GIP) Resolution No. 25 (2018) approved on 18 December 2018;

WHEREAS, the Contract for the Purchase of Color Printers for the National Economic and Development Authority (NEDA) involves the supply and delivery of item below:


NOW THEREFORE, the **Procuring Entity** and the **Supplier** have agreed on the following:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Contract, to wit:
 - (a) Bidding Documents, consist of:
 - i. Invitation to Bid;
 - ii. Instructions to Bidders;
 - iii. Bid Data Sheet;
 - iv. General Conditions of Contract;
 - v. Special Conditions of the Contract;
 - vi. Schedule of Requirements, and Technical Specifications; and
 - vii. Terms of Reference;
 - (b) Supplier's Bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents/statements contained in the Bidder's bidding envelopes, as annexes;


- (c) Bid Bulletin No. 01 issued on 13 November 2018;
 - (d) Performance Security (NEDA OR No. 8209906);
 - (e) NBAC-GIP Resolution No. 24 (2018);
 - (f) Abstract of Bids and Post-Qualification Evaluation Report;
 - (g) Notice of Award of Contract and the Bidder's *conforme* thereto;
 - (h) Notice to Proceed;
 - (i) Addendum and/or Supplement to the Contract, if any; and
 - (j) Other contract documents that may be required by existing laws and/or the Procuring Entity
3. In consideration of the payments to be made by the **Procuring Entity** to the **Supplier**, the **Supplier** hereby covenants to deliver said services and to remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The **Procuring Entity** hereby covenants to pay the **Supplier** in consideration for the delivery of said services, the **Contract Price** or such other sum, as may become payable at the time and in the manner prescribed by this Contract.
5. The **Supplier** is hereby required to post a warranty security, which shall be covered by either retention money in an amount equivalent to one percent (1%) of every progress payment, or a special bank guarantee equivalent to one percent (1%) of the total Contract Price after acceptance by the **Procuring Entity** of the delivered supplies. The said amount shall only be released after the lapse of the warranty period. Provided however, that the supplies delivered are free from patent and latent defects and all the conditions imposed under the contract have been fully met.
6. When the **Supplier** fails to satisfactorily deliver goods under the contract within the specified delivery schedule, inclusive of duly granted time extension, if any, the **Supplier** shall be liable for damages for the delay and shall pay the **Procuring Entity** liquidated damages, not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods scheduled for delivery for every day of delay until such goods are finally delivered and accepted by the **Procuring Entity**.
7. The **Procuring Entity** need not prove that it has incurred actual damages to be entitled to liquidated damages. Such amount shall be deducted from any money due or which may become due to the **Supplier**, or collected from any securities or warranties posted by the **Supplier**, whichever is convenient to the **Procuring Entity** concerned. In no case shall the total sum of liquidated damages exceed ten percent (10%) of the total contract price, in which event the **Procuring Entity** concerned may rescind the contract, without prejudice to any further action it may lawfully take to recover whatever losses it incurred.
8. Any amendment, modification or addition to the terms under this contract shall be made in writing and signed by the parties and/or their authorized representatives, otherwise, it shall not bind the parties hereof.
9. The **Supplier** hereby covenants to supply and deliver said services to the **Procuring Entity**, within thirty (30) calendar days from receipt of the Notice to Proceed.
10. Should any dispute related to this Contract and/or the rights of the Parties arise, the same shall be submitted to mutual consultation, mediation and arbitration, in the order of application. The venue of the proceedings shall be in Pasig City.
11. In case of a court suit, the venue shall be the courts of competent jurisdiction in Pasig City, to the exclusion of all other courts.


