The building has an integrated Security Solutions composed of CCTV Surveillance System with Facial Recognition, Barrier Gates at Entry and Exit Points, Underground Camera and Barrier Gates for Vehicle Inspection, Turn-style Gate Access System, Walk-through Body Scanner, Signal Jamming System, Aerial Drone and Aerial Drone Jammer, UHF Handheld Radio, and Inmate Tracking System.
