Alert Mechanism Leading Indicators:**FINANCIAL**

- 1a Ratio of actual loan proceeds disbursements to target loan proceeds disbursements is less than 70%
- 1b Ratio of actual grant proceeds disbursements to target grant proceeds disbursements is less than 70% (for grants only)
